

COOKIE POLICY

What are cookies?

Cookies are small text files that browsed websites (so-called "first parties"), other sites or web servers (so-called "third parties") process and store in the user's terminal. While first-party cookies are stored on the user's device directly by the browsed website, third-party cookies are placed on the user's device by a third party, like an advertiser or an analytic system.

Cookies can serve **various purposes**, such as electronic authentication, session monitoring, storage of information on specific configurations concerning users who access the server, sending ads that are in line with the preferences showed by users as they browse the web, etc.

Depending on the purpose which they are collected for, cookies can be classified into:

- a) **technical cookies**, which serve the sole purpose of ensuring normal navigation and the use of the website's features;
- b) **profiling cookies**, which aim to create a profile of single users, in order to send advertising messages in line with preferences demonstrated by the users themselves through their browsing behaviour.

Cookies can also provide information on the browsing experience of the website (for example, the number of users on a website, how long they stay on the site for, and what parts of the site they visit): these are the so-called **analytics cookies**. None of this information can be used to identify a single user: it is all aggregated and, therefore, anonymized. Their sole purpose is to improve the website's functions. Given that analytics cookies don't allow single users to be recognized and profiled, the same legal basis as technical cookies applies.

Which cookies does this website use?

This website uses only technical and anonymised analytics cookies.

In relation to technical and anonymised analytics cookies, processing is a necessary requirement for the performance of the contract, to which the data subject is a party, concerning the use of the website and its features (Article 6, point b) GDPR).
